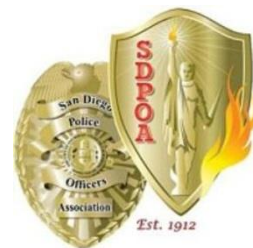




"Ride to Remember 2018"
